



CITY TAXES

Whilst most taxes are generally included in our room rates, there are a few exceptions to this rule, as mentioned in our terms and conditions. These exceptions are detailed below. We are unable to include these taxes in our rates and all passengers must pay these locally directly to the hotel.

The information provided below is for guidance only. Whilst every attempt will be made to reflect the actual charges that will be made locally, B&A cannot be held responsible for the accuracy of this information.

Aix en Provence, France

Please note that a compulsory city tax is required to be paid by the GUESTS on top of B&A's contracted rates on selected hotel accommodation in Aix en Provence, France. The fees are as follows:

- € 1.35 PER PERSON PER NIGHT for stays in 5 and 4 star hotels
- € 0.95 PER PERSON PER NIGHT for stays in 3 star hotels
- € 0.85 PER PERSON PER NIGHT for stays in 2 star hotels
- € 0.65 PER PERSON PER NIGHT for stays in 1 star hotels

EUROPE

AUSTRIA

Tourismusgesetz and **Beherbergungsbeiträge** are just two of a plethora of terms Austria uses for accommodation taxes. The name and how much is levied varies across Austria's nine provinces.

The tax is payable on overnight accommodation (including caravans/campsites), currently ranging from €0.15 to €2.18 per person per night. For a quick overview refer to pages 24 and 25 of this pdf: [Inventory of taxes](#).

BELGIUM

At a national level the reduced VAT rate of 6% applies to Belgian hotels and restaurants (the standard VAT rate is 21%). At a local level Belgian local city tax varies from municipality to municipality.

Details of the local tax applicable in the major tourist destinations of Antwerp, Bruges, Brussels and Ghent follows:

Antwerp / Antwerpen

As of 01 January 2014 a new city tax was scheduled to be introduced in Antwerp to replace the existing complicated system. Source Visit Antwerpen - Official tourism portal of Antwerp Tourism & Convention.

From 01 January 2014 a fixed tax of 2.25 euros excl. VAT (2.39 euros incl. VAT) will be payable per person and per night that this person stays in Antwerp.

A reduced tax of 0.5 euro excl. VAT (0.53 euro incl. VAT) will be levied on camp sites and sites for campervans. This amount will be added to the invoice of your accommodation.**

The City of Antwerp will use this revenue for clean streets, information services, the maintenance of museums, improved mobility, safety and urban renewal.

** Accommodation which falls under the Flemish Parliament Act for Tourism for everyone and individuals under 12 are exempt from city tax.

Bruges / Brugge

Due to city regulations, the city tax will be raised to 2,12 euro p/p per night. Starting from 1st January

2015. It is not included in the rate and is payable to the hotel directly and will be applied to all guests as from the age of 18.

Brussels / Bruxelles

Brussels City Tax is detailed in the "**Taxe sur les établissements hôteliers.**"

How the tax liability is collected is determined at borough and/or hotel level is both too varied and abundant to be meaningfully tabulated.

Ghent / Gent

Ghent has a City Tax of €2.50 per person per night. Some hotels include City Tax in the room rate; whilst others break out the cost and charge the City Tax as a supplement.

BULGARIA

Bulgaria has a City Tax or Resort Tax that is levied on visitors, which varies by municipality and is defined by the Tourism Law. The Bulgarian currency is Lev (BGN) which is currently worth €0.51.

The **City Tax** is a per person per night charge, varying by grade and location. In Sofia 5-star hotel residents pay 3.00 BGN per person per night. A lower amount applies to 4-star and 3-star hotels.

The **Resort Tax**, used in areas such as the Litoral, is different in structure with some resorts collecting a levy on a per stay rather than per night basis.

Value Added Tax was in the news In April 2011 when authorities imposed a Reduced 9% VAT rate (Standard rate 20%) on the tourism sector, replacing existing rates of 7% for organised groups and 20% for individuals.

CROATIA

In Croatia tourist accommodation tax is known as Sojourn Tax. Visitors aged 18 or over face a tax of between 2kn (€0.25) to and 7kn (€1) per day depending on the category and season.

Each town or city municipality falls into one of four Categories, e.g. Dubrovnik is Category "A", but finding a list, definitive or otherwise, of which category a place belongs has proved elusive.

Each Category has four basic seasons BUT please note the date periods do vary by location.

Children under the age of 12 are exempt from paying the tax. There is a 50% discount for those between the ages of 12 and 18.

FRANCE

A new Luxury Hotel Tax on rooms costing more than €200, designed to reap ca. €90m, was scrapped in November 2011, just weeks after being introduced. On the face of it good news but in truth smoke and mirrors. for the fact that it was coupled with the announcement that the reduced rate of TVA (*Taxe sur la valeur ajoutée*) will increase from 5.5% to 7% (whilst the standard rate 19.6% rate remains unchanged, it is the reduced rate that applies to hotels).

France already levies **Taxe de Sejour** on the hospitality industry, which is summarised in the table below.

Explorers Hotel at Disneyland Paris ID 16543: Note that from 13/11/15 the city tax will be 1.10€ per person/per night and will be paid locally by the guests.

GERMANY

Kulturförderabgabe (Culture Tax) or **Bettensteuer** (Bed Tax) are the terms used for accommodation taxes in Germany.

In 2010 there was an explosion of such hotel taxes across Germany, possibly in reaction to a reduction in the VAT rate leaving local authorities short of funding. Worth noting too, of the cities imposing this tax, many impose it on top of the VAT inclusive rate, making it a double whammy: a tax on a tax. Dehoga/IHA (German hotel associations) are ardently opposed to these taxes.

In July 2011 Munich's attempt to introduce a €2.50 per person flat rate bed tax was successfully thwarted when the **Bayerische Verwaltungsgericht München** (Bavarian Administrative Court of Munich) upheld a complaint by the Government of Upper Bavaria against the Munich local authority. The decision was welcomed by the Deutscher Tourismusverband (German Tourist Association).

Aachen, Bremen/Bremerhaven, Hamburg and Lübeck all announced that a bed tax will be introduced in 2012. More alarmingly in November 2011 local authorities in Berlin sanctioned the introduction of a bed tax, although it is not yet law and when (if) it does will not come into force until 2013.

Dortmund and Cologne

New statutes regarding local accommodation and tourism taxes (hereinafter named City Tax) for the cities

Dortmund and Cologne have applied. Dortmund's new taxation model started on 1st November 2014; Cologne's statute on 1st December 2014. Please bear in mind that those two statutes have a substantial change: From now on, the guest is debtor and not the accommodation provider. This has a direct impact on the price lists published so far.

For our FIT partners we included the City Tax in Dortmund's and Cologne's rates. However, with the above mentioned amendments the City Tax is definitely not a price component anymore. Should your guests be tax-exempt, they will have to prove it at check-in. Otherwise we are forced to collect the tax on site.

For our partners in the group segment no changes to the normal handling occur. In both statutes, no explicit reference is made with regards to schools. Until this matter is resolved, A&O will not charge school classes at its own risk if the teacher provides a corresponding proof that the trip happens due to an obligatory educational cause. A&O provides those forms.

Group trips with an amusement purpose will be charged with the city tax on the spot.

Kindly note that B&A will not be responsible for this augment and hotels will ask guests to pay it during their stay. We ask you to notify your clients with related bookings in India that guests will be requested to pay 10% GST directly at hotel

ITALY

Tassa di soggiorno is the term in general use for the swathe of local tourist taxes that began being introduced across Italy in 2011.

Generally the tax is a **Euro amount corresponding to the hotel's star rating** and levied on a set number of nights: the maximum number of nights threshold to which the tax is applied, varies widely from place to place. The picture in Venice is further complicated by a myriad of conditions regarding location, mode of transport, and season.

When you add these new taxes to the existing IVA (Italian VAT) element and the vast array of coach permits and parking fees (with **Florence** the most expensive and **Venice** again the most complex), a **standard 7-night tour of Italy can cost upwards of €100 per person in hotel taxes and coach fees**. These surcharges only serve to harden Italy's reputation as one of Europe's most expensive tourist destinations.

The table below focuses on the High Season picture, but there are a multiplicity of seasonal variations which cannot be encapsulated here:

The **# of NTS** is the **maximum** number of consecutive nights on which the tax in that destination is applied.

In **ALBEROBELLO** there is no consecutive night threshold when the tax is no longer charged.

In **ANCONA** the tariff is €0.50 each for a room costing up to €20 per person, €1.00 each for a room costing between €20.01 & €50.00 per person, €2.00 each for a room costing between €50.01 & €100 per person, and €3.00 each for a room over €100 per person. Chargeable on stays of up to 15 nights.

In **BERGAMO** there is an additional €2,00 category, with the levy applicable to holiday homes (rooms, houses, apartments, cottages) and bed & breakfast establishments. Additionally the levy for each of the hotel categories can be increased or decreased by €0.50 depending on the amount spent on the total stay.

In **BOLOGNA** the city tax is payable based on rates bands as follows:

CATANIA's website **contains** all the necessary information. The tax was increased from 2011 to 2012 by 100% in the 1-star/ 2-star categories and 50% in the 3-star/4-star categories.

In **COURMAYER** the tax is determined the tax by the average room rate: For an average daily room rate of €20 the levy is €0.20 per person per night; from €20.01 - €40 it is €0.40 per person per night (pppn); from €40.01 - €70 it is €0.80 pppn; from €70.01 - €100 it is €1 pppn; from €100.01 to €200 it is €2 pppn; and €200.01 upwards it is €3 pppn. Children under the age of 10 and bus drivers and tour guides accompanying a group of over 25 passengers are exempt.

In **MONTECATINI TERME** there is a 10% reduction in the months of January & December.

The Comune di **MONTEPULCIANO** website contains all the pertinent information. The tax is levied on ALL nights, with no ceiling on the maximum number of nights it is charged on.

In **PALERMO** the tax is applied for a maximum of 4 consecutive nights per person per night. Children up to 12 are exempt from paying the city tax.

In **PISA** the High Season is deemed to be the inclusive period from the Monday before Easter to the first Sunday in November. During the low season the maximum number of nights the tax is levied on drops from 5 to 3 consecutive nights.

In **ROME** tourists will also be made to pay an additional €2,00 (\$2.70) tax on museum tickets. City tax is applied per person per day. Children under the age of two years are exempt from city tax payment.

In **TURIN** City Tax in 3* hotels is €2.80 per person, per night from 01 October 2014. The amount increase to €3,70 per person, per night for 4* hotel. It is not applicable to children under 12 years old. This is a governmental tax and will be added to the room rate.

VENICE has two tax seasons: High and Low. The High Season is deemed as: (a) the duration of the Venice Carnival, (b) Easter as defined by the Wednesday prior to the Tuesday after, (c) from 01 April to 31 October, (d) the whole of the week in which 08 December falls, and (e) from 23 December to the first Sunday after 06 January inclusive. The Low Season is deemed any date outside the High Season. This is a taster of how complex the regulations in Venice are structured.

Imposta sur Valore Aggiunto (IVA): In September 2011 the standard rate of IVA rose from 20% to 21%, with a further rise to 23% scheduled in 2012. The reduced rate of 10%, which applies to hotels, will increase to 12% in October 2012. A further 0.5% increase for standard and reduced rates is scheduled for 2014.

NETHERLANDS

In The Netherlands tourist accommodation tax is called **Toeristenbelasting**.

A levy per person per night is charged in almost all of the 421 municipalities with the majority charging a set amount that varies according to grade and accommodation type. The remainder either charges a percentage, which may also vary by hotel grade/accommodation type, or nothing.

PORTUGAL

In September 2010 Lisbon's Mayor Antonio Costa admitted that his administration was considering introducing a two-tiered tourist tax along the lines of the following:

- a €1 tax on all visitors arriving in London
- a hotel bed tax of up to €1,90 per person per night

Ironically this came in the wake of the announcement that the Portuguese capital had won TripAdvisor's "Most Affordable Holiday Destination" award.

To date there have been no further developments, which maybe due more to Portugal's rather delicate economic situation than any thing else. In a reappraisal of Portugal's VAT rates towards the end of 2011, the Reduced VAT rate of 6% applicable to hotels was maintained, but the restaurant trade was hit with a hike from 13% to 23%.

ROMANIA

City tax is 1% of the room rate per person per night. This applies to all hotels regardless of the category and star rating.

Tourists under the age of 18 are exempt.

RUSSIA

A news story in October 2011 circulated that **Moscow** is planning to tax tourists between €1 and €3 per day, with the money to be used to improve tourist facilities and renovate popular attractions. There is a caveat though and that is that the measure will only be introduced if the number of visitors to Moscow shows a steady increase. The city hopes the number of foreign visitors will reach 6 million people by 2016 (in 2010 the figure was around 4 million).

In 2010 **St. Petersburg** considered a similar scheme. Governor Valentina Matvienko suggested introducing a special "tourists fee" adding that "\$1 per day is no money". To date St. Petersburg has taken this no further.

SLOVAKIA

Limited information available. Referred to as a **City Tax** or a **Tourist Tax** or even a **Village Tax**, the amount levied varies from €0.50 to €1.65 per person per night.

SLOVENIA

Slovenian tourist tax law is detailed in the **zakon o spodbujanju razvoja turizma** (ZSRT), which is the name of the parliament Act on the Promotion of Tourism Development.

Generally this is a tax of between €0.60 and €1.25 per person per night, but it does vary by both location and hotel grade. In Ljubljana there is a daily tourist tax of between €0.62 and €1.25, whilst in Vaneča, Fokovci, Vino and Moravske Toplice the tax is currently €1.01 per person per night for adults.

The reductions/exemptions applicable to children also vary from place to place. For example using the above destinations: in Ljubljana at least one hotel states children aged between 3-

12 get a 40% discount and those aged under 3 are exempt; whereas in Vaneča, Fokovci, Vino and Moravske Toplice it is a uniform 50% discount for children aged between 7 and 18, with those under the age of 7 exempt.

SPAIN

In July 2010 Barcelona Turisme was understood to be considering the possibility of introducing a tax on tourists in a bid to compensate for a reduction in state subsidies. A 1% rise in VAT shortly afterwards put paid to this, temporarily it seems. The story resurfaced in May 2011 when Jordi Portabella, the Vice President of Barcelona Turisme, was quoted as saying a tourist tax was on the cards, but gave no schedule. **In December 2011 a hotel tax in Barcelona has become a reality** when the Generalitat of Catalunya announced a **tasa turistica** will be levied on all hotels in Catalunya commencing on **01 April 2012**. CEHAT (Confederación Española de Hoteles y Alojamientos Turísticos) are one of several hotel associations that immediately came out in opposition to the tax, citing it as an irrational and unfair one.

As only PART of the proceeds will be allocated for the development of tourism, it shows that the underlying intent of the tax is primarily to garner funds arbitrarily.

SWITZERLAND

Here there is a rather complex tax model, comprised of 2 elements: **Beherbergungsabgabe (BA tax)** and **Kurtaxe**, which are percentage amounts determined by the grade of the hotel.

The **BA tax** revenues are used to finance tourism advertising and to maintain/improve the region's infrastructure, with the proceeds being split between the Canton and Local Tourist Authority (LTA) for this purpose.

The proceeds of the **Kurtaxe** are wholly used to improve the tourism experience for visitors and the LTA holds the purse strings.

However, since each Canton can determine its own model there are further variations: e.g. in Lucerne there is a third element to the tax, the Lucerne Hotel Tax, which is neither part of the BA tax nor Kurtaxe construct. The proceeds are intended for the benefit of the hotels.

With such unilateralism across cantons, it would be impossible to compile a table/chart without contacting every Canton and thereafter most hotels.

UKRAINE

At the start of 2011 a tourist tax was introduced in Kiev. Thereafter it spread across the rest of Ukraine with the local authorities in Ivano-Frankivsk, Kamianets-Podilsky, Lviv, Lutsk, Odesa, and Ternopil, as well as the Autonomous Republic of Crimea all following suit with similar levies.

All to date have introduced a 1% tax on the hotel room cost exclusive of breakfast. The tax also applies to campsites and hostels but there may be regional variations to this.

MALAYSIA

Penang Island

The government has introduced a new tax fee for all Penang hotels that guest have to pay directly to the hotel. The tax is MYR 3,00 per room per night and comes into affect into 1 Jun 2014.

Effective **1 September 2018**, the Malaysian government will introduce Sales & Service Tax (SST) to replace the Goods & Services Tax.

Under the SST regime, hotel accommodation is a taxable service and will be subjected to 6% service tax.

Please note that Hotels will collect the SST amount directly from customers upon their arrival or upon their check-out.

MOROCCO

Please note that city tax (per person per night) can be asked to be paid directly to the hotel in the cities below. The amount of this tax depends of the hotel.
